Parks and Recreation Request

Director Pictor explained the Parks and Recreation board will be seeking as many grants as possible for projects on the list to assist with funding.

Proposed Ordinance Related to Short Term Rentals and Bed and Breakfast Establishments

Those provisions need to be made to bring the current document up to date that was presented to the court in February 2023 by the Planning Commission. The current proposed amendment for first reading does not consolidate those provisions. Planning and Zoning Director, Steve Hunter discussed the administrative process going forward once criteria is passed.

2. A motion was made by Darrell Varner and seconded by Mary Ann Gill to direct and authorize the County Attorney to consolidate all provisions from previously passed Ordinance 2023-07, amending Article VII, to the proposed Ordinance to be presented to the court prior to a first reading.
