#### **APPROVAL OF MINUTES**

#### **COMMITTEE REPORTS**

The Personnel Committee met prior to the Regular Meeting of the Fiscal Court for the sole purpose of meeting in closed session pursuant to KRS 61.810(1)(f) to conduct candidate interviews for the Assistant Tax Administrator position. The committee authorized the Judge/Executive to negotiate with the candidate.

The Committee of the Whole met prior to the Regular Meeting of the Fiscal Court on November 28, 2023, with all Magistrates present with the exception of Magistrate Jackie Brown to discuss the proposed first reading of Ordinance 2023-17 relating to short term rentals and bed and breakfast establishments. Action taken is reflected in the Special Meeting minutes from November 28, 2023. The committee also discussed the Woodford County Fire District funding request for a new jaws of life. As reflected in the November 28, Special Meeting of the Committee of the Whole minutes, the committee approved to refund the fire district for the full amount of a new set of battery powered jaws of life which will be the fire districts full responsibility to maintain, and the Woodford County Fiscal Court no longer is responsible for maintenance and upkeep of said equipment. The Neighborhood Grant Program was discussed, and the committee took action to approve the Neighborhood Grant Agreement between Locust Grove and the Fiscal Court.
