Huntertown Community Interpretive Park - Sioux Finney

Sioux Finney shared that the Huntertown Community Interpretive Park was honored to be included in the Ida Lee Willis Memorial Foundation and Kentucky Heritage Council – State Historic Preservation Office 2024 State Preservation Awards. Friends of Huntertown Community Interpretive Park received the Grassroots Preservation Award on May 22, 2024, at the National Landmark Old State Capitol in Frankfort. The Grassroots Preservation Award is given at the selection committee's discretion and celebrates those who have committed their personal time and resources to successfully take on a challenge that addresses a preservation issue at the local level.
